General Eligibility and Terms

- Rebates are available to Black Hills Energy (BHE) commercial natural gas customers. Gas transport customers are not eligible for rebates.
- Purchase and installations must be completed between Jan. 1 and Dec. 31. All application materials for completed work must be received by December 31st.
- All Custom projects require approval before the purchase and installation of measures.
- The commercial/industrial Custom Rebate Program incentives pay a 2-year payback, or up to 50% of the incremental cost of the equipment. There is a \$50,000 per-project cap.
- All projects will be individually reviewed by Black Hills Energy and must pass a cost-effectiveness test.
- Funding for these rebates is limited. Applications will be processed on a first-come, first-served basis.
- Once a project is completed, an invoice or other documentation must be submitted and reviewed before incentives can be paid.
- Rebates may be subject to federal and/or state income tax reporting. Applicant is responsible for contacting a qualified tax advisor to determine tax liability. Black Hills Energy is not responsible for any tax consequences of the rebate program.

Black Hills Energy does not guarantee that installation of equipment qualifying for rebates will result in reduced energy usage or demand, or in cost savings.
